Does hereby acknowledge the dangers and assume the risks when renting, operating or using the SEA SCOOTER; dangers inherent to swimming, diving and conducting water sport activities, such as (but not limited to) danger of drowning, injury and death, for example due to stream and water influent of (rapidly) emerging weather changes at sea, or other consequences of natural forces, eddies, large waves, risks associated with snorkeling and diving underwater, dizziness, collisions with other objects in the sea or water, exposure to direct contact with (potentially) dangerous or poisonous marine animals, insects, marine plants or other objects, sunburn and heat illness, injury or damage from improper use of the SEA SCOOTER, such as improper lifting, lifting, carrying, diving too deep, or any other injury caused by use, including wrist, arm, shoulder and/or back injuries, etc.

The undersigned declares to have received instructions of the limited liability company, Rent Adventure Curaçao B.V. on how to use and handle the SEA SCOOTER and other matters that need extra attention, such as maximum depth, battery life, possible ear pressure, required swimming skills, entanglement with items such as (swimming trunks/suits/bikini) draw strings, waterproof bags, etc.

The undersigned declares to be aware of possible consequences that may arise from the use of the SEA SCOOTER, he also declares to be in good health, and that he/she masters the required swimming skills and techniques to operate the SEA SCOOTER.

The undersigned acknowledges to have read and understand the following rules:

- i. the undersigned takes responsibility to operate the SEA SCOOTER in a safe way;
- ii. the undersigned will not go into sea at a depth of more than three meters;
- iii. the undersigned will not transfer the operation of the SEASCOOTER to third parties;
- iv. in case the undersigned allows anyone other than himself/herself to use the SEA SCOOTER, he/she states to be aware that such use is fully and completely at his own expense and risk.
- v. the undersigned is aware that the use of a full face snorkel mask is not recommended.
- vi. the undersigned is aware that loss of or damage to the SEA SCOOTER will always be at the expense of the undersigned and must be compensated.



The undersigned does hereby remise, release, and discharge the private company Rent Adventure Curaçao B.V., its directors, employees and workers, its auxiliary staff and other persons affiliated with it from all liability for any damage or injury or the consequences because of that the undersigned has suffered or may suffer as a result of using the SEA SCOOTER. In the event that the undersigned has rented the SEA SCOOTER and has made it available to another person, including family or relatives, friends, acquaintances and others, he/she will take full responsibility for all damage as a result of usage from a third party and making it available to this third party. The undersigned therefor indemnifies the undersigned Rent Adventure Curaçao B.V. for such damage and (legal) claims, including any costs of legal assistance, collection costs, legal costs and other costs associated with such measures both for and against Rent Adventure Curaçao B.V.
